### NOTICE TO EXHIBITORS

**ELIGIBILITY TO ENTER** This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the Fetch test. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs are allowed to enter so long as the handler is in control of the dog at all times, the dog can complete the requirements of the test, and the dog does not appear to be under undue stress in the opinion of the judge.

**OPENING DATE** is Sunday, August 25, 2024. **CLOSING DATE** for the test is 5:00 p.m., Wednesday, September 25, 2024, after which time entries will not be accepted, canceled, altered or substituted.

MAIL ENTRIES. Send entries with \$20 per class fee to: Pat Etchells, Test Secretary, 103 Columbia Crest Drive, Grants Pass, OR 97526. Entries not on official AKC entry forms are not acceptable. Incomplete or illegible entries or entries without fees WILL NOT be accepted. MAKE CHECKS PAYABLE TO "RVKC". CANADIAN/FOREIGN exhibitors must make fees payable in U.S. FUNDS drawn on a U.S. bank. If you are entering more than one dog, please send a separate check for each dog. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

ENTRY LIMITS. Entries will be limited to 30 dogs per test and will be determined on a first-come basis. RVKC is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 20 entries per test will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to CLOSING DATE. No entries may be withdrawn with a refund after CLOSING DATE. If an entry withdrawn prior to closing date is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

**ELECTRONIC ENTRIES ACCEPTED.** Scan/take a photo of the entry and email it to: RVKC.match@gmail.com. Make a \$21 payment (includes \$1 PayPal fee) per class via PayPal to RVKC at **roguevalleykc@gmail.com** (NOTE: Different e-mail addresses!!!) making sure the owner's name and "fetch dog test" are indicated in comments.

**ERRORS ON ENTRY BLANKS**: Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded, in the event of such errors or cancellation of entries after the published closing date.

**REFUNDS.** No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs withdrawn after closing because of injury or other medical condition are not eligible for a refund.

**Bitches in season** will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

AWARDS. The Rogue Valley Kennel Club will present a ribbon to each dog rated "passed".

SIGN-IN and CRATING AREAS. There will be a secretary table for check-ins and information. Dogs will be crated out of view of the Fetch test area, or far enough away as to not cause a distraction to the dog being tested.

**ADDITIONAL SITE INFORMATION.** Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

SAFETY, BEHAVIOR and LIABILITY. The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. Rogue Valley Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. Rogue Valley Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against Rogue Valley Kennel Club or any official thereof.


**COLLARS, LEASHES & HARNESSES.** Dogs must wear a collar. Dogs may wear slip collars, buckle collars, and Martingales in the AKC Fetch test. They may not wear prong collars, e-collars, head collars, muzzles or body harnesses. Leashes should be 4 ft. to 6 ft. long and should be made of fabric, leather, or biothane. No flexi-leads permitted.

**RINGSIDE.** Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**EXHIBITOR CHECK-IN:** You will receive your armband number at checkin. All exhibitors will be notified by email once the time and location for check-in are determined. <u>Exhibitors MUST check-in EACH test they</u> <u>are entered</u>
