NOTICE TO EXHIBITORS

CLOSING DATE for the test is 5:00 p.m., Thursday, March 19, 2026, after which time entries will not be accepted, canceled, altered or substituted.

NO DOG MAY BE ENTERED IN THE TD TEST unless it has been certified by a licensed Tracking Judge or evaluator. **THIS CERTIFICATION MUST** be included with the entry. A TD/TDU/TDX/VST dog may continue to participate, but preference in entries will be given to dogs which have not yet passed the TD/TDU/TDX/VST test.

NO DOG MAY BE ENTERED IN THE TDX TEST until notified by the American Kennel Club that it has earned the TD or TDU title. A TDX dog may continue to participate, but preference in entries will be given to dogs which have not yet passed the TDX test.

MAIL all entries with fees to: Liz Aghbashian, RVKC Test Secretary, 2784 Honor Drive, Medford, OR 97504. Entries not on official AKC entry forms & photocopies of entry forms without the Agreement and Rules on the reverse side of the official AKC entry form are not acceptable. Incomplete entries or entries without fees or necessary certification **WILL NOT** be accepted.

ERRORS ON ENTRY BLANKS: Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded, in the event of such errors or cancellation of entries after the published closing date.

ENTRY FEES include \$.50 AKC recording fee and \$4.50 event service fee. A written statement must accompany each entry for a licensed or member tracking test for any dog that has not previously passed an AKC TD or TDU test. This statement must be dated within two years of the date the test is to be held, signed by either a person approved to judge tracking tests, or by a person/evaluator who has handled a dog to a TDX or VST title within the last ten (10) years, and must certify that the dog has satisfactorily performed a certification test.

MAKE CHECKS PAYABLE TO "RVKC". CANADIAN/FOREIGN exhibitors must make fees payable in U.S. FUNDS drawn on a U.S. bank. If you are entering more than one dog, please send a separate check for each entry.

TELEPHONED, TELEGRAPHED, UNSIGNED, OR ENTRIES WITHOUT FEES CANNOT BE ACCEPTED. No entry shall be made and none accepted which specifies any conditions as to its acceptance. Returned checks do not constitute a valid entry fee and will have to be made good with cash or a money order prior to the draw for tracks. The Test Secretary will add a collection fee to the amount of each returned check.

ENTRIES shall be accepted up until the official closing date, even though the advertised limit has been reached, and a drawing will be held within 48 hours of the closing to determine which entries will participate in the test.

IF THE ENTRY is exceeded, a drawing will be held Thursday, March 19, 2026, at 7:00 p.m. via Zoom. A link will be emailed to all entrants beforehand, and others can request it from rvkc.tracking@gmail.com. When the advertised limit is reached if there are more entries, the drawing will continue to establish a list of alternates. Following the draw, the Test Secretary will promptly notify all entrants of the outcome. Alternates will be given the option to accept or deny being placed on the list of alternates. If they decline, their entry fee (and certification) shall be returned. Entrants and alternates who are not given the opportunity to run a track shall have their entry fee (and certification) returned. (AKC Tracking Regulations, Ch. 1 Sec. 17) Alternates are required to be at the Test site at the time of the **DRAWING FOR TRACKS**. If an entrant is absent, the alternates will draw in the order listed in the catalog. **NO** entry fees will be returned after the closing date except as specified above.

JUDGING SCHEDULES will be e-mailed the week prior to the test.

DRAW TIMES FOR TD - 7:30 a.m. TDX - 10:30 a.m.

IF because of riots, civil disturbances, or other acts beyond control of the management it is impossible to open or complete the test, **NO REFUND OF ENTRIES WILL BE MADE.**

BITCHES IN SEASON MAY PARTICIPATE. The Test Secretary and Judges **MUST** be notified of each bitch in season **PRIOR** to the drawing for **TRACKS**. The last tracks to be laid on that day shall be reserved for the bitch(s) in season. Bitches in season shall be allowed on the tracking field **ONLY** immediately prior to their running and **NOT** while **ANY** other dog is working. (AKC Tracking Regulations, Ch. 2 Sec. 8)

REFUNDS. Entry Fees for an Alternate that does not participate in the Tracking Test shall be refunded within 7 days. In the event an accepted Entry withdraws after the closing date to allow an Alternate to replace said Entry, **THE ENTRY FEE WILL BE REFUNDED.** In the event an Accepted Entry withdraws after the closing date and there is no Alternate to replace said Entry, **THE ENTRY FEE WILL NOT BE REFUNDED.**

EXTREME WEATHER CONDITIONS The Club reserves the right to cancel the test in the case of extreme weather conditions. A message would be on 406-599-9308 if this were the case.

TEST WORKER OPTION will be utilized. Three tracks will be set aside.

ALL DOGS MUST BE ON LEAD AT ALL TIMES.

DIRECTIONS TO TEST HEADQUARTERS

Interstate 5 to Exit Number 35. Blackwell Road, Central Point.
Take Blackwell Road - it will become Kirtland right before the RR crossing. Stay on Kirtland and go through the only light at Table Rock Road. The road then becomes Avenue G. At the blinking light, turn left onto Agate Road and go .3 mile to the gate at Touvelle Road.

Google Maps - "9000 Agate Road, White City, OR" will get you close. (Using "Touvelle Road" will get you lost.)

PLEASE NOTE: VEHICLE USE PERMIT REQUIRED

The Oregon Dept of Fish & Wildlife now requires a Vehicle Use Permit for Denman Wildlife Area. Permits can be purchased online, at an ODFW Office that sells licenses, or at a license sales agent. A daily permit is \$10, and an annual permit is \$30. Permits are transferable between cars, but each car must have a permit displayed on the dash while parked at Denman Wildlife Area. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3 of the *Rules Applying to Dog Shows*.)
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
